- I. **Meeting was called to order at 6:00 pm.**
- II. **Pledge of Allegiance and Prayer:** Pledge of Allegiance and Prayer were said.
- III. **Roll Call for a Quorum:** Matthew Starr- Present, Chuck Willard-Present, Ernie Knight-Present, Debbie Kraulidis-Present, Tony Fremarek-Present
- IV. **Approval of the Agenda:** Supervisor Fremarek entertained a motion to approve the August 13, 2014 agenda as presented by the clerk. Trustee Starr made a motion to approve the agenda for the August 13, 2014 general meeting as presented by the clerk, seconded by Trustee Kraulidis. Voice vote taken. All ayes, motion carries.
- V. **Approval of the minutes from the July 09, 2014 General Town Meeting:** Supervisor Fremarek entertained a motion to approve the minutes from the July 09, 2014 General Town meeting as presented by the clerk. Trustee Knight made a motion to approve the minutes from the July 09, 2014 General Town meeting as presented by the clerk, seconded by Trustee Starr. Voice vote taken. All ayes, motion carries.

VII. Public Comments: Plainfield Township residents Gerald and Tari Heintz of 25763 W. Renwick Road stated they continue to experience drainage and flooding problems. He stated about a year ago, the gas company trenched gas lines down Renwick. He stated since that time, the ditch has not dried up. Mr. Heintz stated he has tried to contact the gas company on several occasions, but has not received a call back. Commissioner Reichert stated there is water all over the area. He stated his crew was working out there today; they cut down all the cattails. Supervisor Fremarek stated the Township and the Highway Department will draft a letter to the gas company.

VIII. Donation Request:

A. Joliet Area Community Hospice, donation request- Ava Shapard, Grant Writer. Ms. Shapard presented an overall view of the services presented by Joliet Area Community Hospice to patients and families in the area. Supervisor Fremarek entertained a motion to donate \$1,000.00 to Joliet Area Community Hospice. IX. Old Business:

- A. Des Plaines Street Site Update: Supervisor Fremarek stated we continue to experience delays in the construction of the Des Plaines Street Site. He estimated an opening date of October 1, 2014.
- B. Sunnyland Update: Ms. French stated she had a meeting last week with Austin Tyler. They have a punch list that needs to be taken care of in order to finalize their scope of the work.

X. New Business:

- A. PHS Alumni Association: Supervisor Fremarek entertained a motion for an annual donation of \$150.00 for a banner supporting PHS Homecoming parade. A motion was made by Trustee Willard to donate \$150.00 to the PHS Alumni Association for the purchase of a banner to be used at the annual Homecoming parade, seconded by Trustee Starr. Roll call taken: Trustee Starr-Aye, Trustee Knight-Aye, Trustee Willard-Aye, Trustee Kraulidis-Aye, Supervisor Fremarek-Aye. All ayes, motion carries.
- B. Discussion: Plainfield Township/Plainfield Township Park District Intergovernmental Agreement. Supervisor Fremarek sent a draft of the Intergovernmental Agreement with the Park District to the board members. The agreement is in regard to; 1. Each agency shall share in the responsibility of the senior coordinator. The Senior Services Coordinator will be considered an employee of the Plainfield Township Park District. Plainfield Township will support the employment of the individual by paying no less than 50% of the salary and benefits as agreed to on a yearly basis. 2. Facility Responsibility: The facility will be under the direction of Plainfield Township. Supervisor Fremarek asked Trustee Willard and Trustee Starr to work with Ms. French on sending a letter of intent to the Park District.
- C. IDOT Route 30 Widening Project: A discussion was held regarding IDOT'S request for \$5,000.00. It was a unanimous decision to disregard the request for

funding. Assessor Kljaich stated she is concerned about the widening of Route 30 and the adverse effect it will have on businesses along Route 59 and Route 30.

- B. Emergency Management Committee:** Trustee Willard stated the Township has 1,000 sand bags on hand and are stored in the new building on Des Plaines Street.
- C. Youth Committee:** Trustee Starr advised the board about the upcoming AITCOY board meeting scheduled to be held here on August 26, 2014. The panel will discuss Violence Management. There will be a presenter discussing his experience in crime and crime victims. All are invited to attend.
