The Governor's Office and the Illinois Department of Public Health activated a Tier 3 mitigation plan for all regions of the State of Illinois, effective Friday, November 20, 2020. In an effort to support these mitigation measures, the Plainfield Township is limiting in person attendance in the meeting room to 10 people.

During the meeting, a group of up to 10 people will be staged in the lobby of the Township Administration building. This group will wait in an area with a live feed to the meeting until the Public Comments on Agenda items section has commenced. Speakers will be rotated into the meeting room to allow everyone an opportunity to speak. Public comments may also be made by attending the meeting via Zoom.
